PLEASE ADD \$150 FOR DRUG TESTING ON CLAIMED HORSES. (IF YOU
WOULD LIKE ONE DONE) FEE IS REFUNDABLE IF THE NYSGC SELECTS THE
HORSE FOR USUAL POST RACE TESTING.

HORSES RACING IN CLAIMING RACES MUST BE CLAIMED OR 123 IN LAST
START TO MOVE UP IN CLASS TO KEEP PREFERENCE. OTHER HORSES MAY
BE USED IF NEEDED TO FIL

Any horse that fails the S.C.R.Blood Gas Testing (TCOS) guidelines established and
performed by S.C.R. will be scratched as will any horse that is determined to be in
violation of the NYSGC rule #4120.

To avoid being scratched and or fined, the trainer of record should be in the
paddock unless said trainer designates another trainer and both trainers have the
proper insurance certificates on file with the commission. For any questions
regarding this policy please call the judges at 585-343-3750 ext.6364 or call the
NYSGC. Unless you have approved workers comp. on file you must paddock the
horse yourself.
