## BATAVIA DOWNS GAMING "Football, Food and Free Play"

Official Rules

- 1. Eligibility: This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Division of the Lottery, and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed by the NY State Racing & Wagering Board as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Limit 1 entry per person per Game Day. Entry form will be a printed receipt from Player's Club. Winning tickets will be drawn from drawing bin at Player's Club at 8:15pm for prizes specified below. Winners need not be present to win.

Year End Drawing will be held on Tuesday, January 9, 2018 at 10am. Entries will be hard draw slips printed from Player's Club. One winner will be chosen for the Grand Prize.
