

BATAVIA DOWNS GAMING
“Gold and Dragon Collect and Win”

Official Rules

1. **Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.

It is the responsibility of eligible entrants to be in an area where winner’s names can be heard over PA system.
3. **Contest Period:** October 1st beginning at 8am- October 31st, 2017 11:59pm
4. **Method of Entry:** Beginning at 8am on October 1st and while game pieces last, Player’s Club members may receive one (1) Official Game Pieces per day for the Collect and Win Game Board by checking into Player’s Club after earning four additional base points separate from daily promotions with their Player’s Club Card. At least one of these points must be earned on an IGT or Spielo Machine. Game Pieces can only be picked up or redeemed during Player’s Club hours. Customers that receive instant win prize game pieces will win prizes as defined in section below. Customers that collect matching game pieces on Collect and Win Game Board will win prizes as defined in section below. There is a limit of one, (1) Game Piece per day per person for this promotion unless a separate promotion day/time allows an extra piece to be earned.

Player’s club members can earn double game pieces and the 4 base points must be earned during these times on the following days in order to receive double pieces:

- Saturday, October 7, 14, 21, 28, 2017 9am to 11am
- Sunday, October 1, 8, 15, 22, 29 2017 from 9am to 11am
- Monday, October 2, 9, 16, 23, 30 2017 from 8pm to 11pm

A valid photo ID must be presented to Player’s Club representative to redeem instant win or matching game pieces. No duplicates, reproductions, or facsimiles of Collect and Win game pieces will be accepted. Presenting false and/or deceptive entries or acts to Player’s Club shall render entrants ineligible. All prizes must be claimed at Player’s Club by Saturday, October 31, 2017 at 11:59pm.
