Official Rules

- 1. Eligibility: This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. Rules: If a present winner cannot produce ID, the following protocol shall be followed: For all Drawings \$999 or less the Batavia Downs staff present shall take down the possible winner's driver's license number found in the Player Tracking System. At any time within 24 hours, the possible winner must return, WITH the driver's license that matches the driver's license number that was logged the day previous and the prize will be awarded. If the person fails to show, the prize is forfeited. For all drawings \$1000 or more, the staff present shall take down the possible winner's driver's license number found in the Player Tracking System. The possible winner must designate a 1 hour window within the following 24 hours of the drawing time to return to claim their prize by presenting the driver's license that matches the driver's license number that was logged the day previous. If the person fails to show, the prize is forfeited.
- 5. <u>Method of Entry</u>: Patrons will earn (1) entry for each non-winning \$2 "Neon 10's" New York Lottery ticket shown at Players' Club. Limit 50 total tickets per person, per week. Contestants will show ticket at Player's Club

and Player's Club Staff will stamp the ticket with permanent marker so that the ticket cannot be resubmitted for another entry. Hard Entry Slip will be printed at Player's Club and placed into drawing bin. At times specified above for prizes below the two winners will be drawn from drawing bin at Player's Club. Winners do NOT NEED to be present to win prizes. Winners will be notified via information in their account that they have won prize. Winners have 1 week to pick up prizes at Player's Club or their prize is forfeited. Players may only win one (1) 2nd Chance \$100 FP Drawing, Per Day. A player that wins a \$100 FP drawing may also win the final \$250 FP Drawing.
