Official Rules

1. **Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules. Players may only be awarded one “like” prize per drawing date. (I.E. if a player is awarded a \$500 Cash prize they are eligible for any other drawings that night except for another, separate \$500 Cash Prize).

4. **Method of Entry:**

Virtual Drawing: Customers playing at any BDG VLT machine with their Player’s Club Card during specified promotional times beginning February 3 until February 23rd will earn virtual entries into drawings. Patrons will earn (1) entry for every \$25 of coin played. No limit on entries. To activate their entries, players must play with their Players club card on any VLT machine at any point between 2 hours to half hour for the 5pm drawing, 2 hours to half hour for the 6pm drawing, 2 hours to half hour for the 7pm drawing, 2 hours to half hour for the 8pm drawing, 2 hours to half hour for the 9pm drawing, and 2 hours to half hour for the 10pm drawing on the day of the drawings to ensure activation. Drawing Winner will be selected and verified at 10 minutes to drawing time with the winner will being announced at 5pm, 6pm, 7pm, 8pm, 9pm, and 10pm. The winner of drawing will have 5 minutes to report to the Player’s Club to claim their prize or a new name, different than all previously

selected names for the same drawing, the same prize, drawn on the same day, will be drawn. Winner MUST be present to win and present a valid photo ID acceptable by NYS Gaming Commission.
