

**BATAVIA DOWNS GAMING**  
**“Shamrock Progressive Drawings”**

**Official Rules**

**1. Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.

**2. Sponsor:** (as defined below), Western Regional OTB, Batavia Downs Gaming, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer on-line system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications, data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. This also includes any malfunction with respect to a Player’s Club card. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrants ineligible. Batavia Downs Staff will announce winners over PA system. It is the responsibility of eligible entrants to be in an area where winner’s names can be heard over PA system.

**3. Rules:** If a present winner cannot produce ID, the following protocol shall be followed: For all Drawings \$999 or less the Batavia Downs staff present shall take down the possible winner’s driver’s license number found in the Player Tracking System. At any time within 24 hours, the possible winner must return, WITH the driver’s license that matches the driver’s license number that was logged the day previous and the prize will be awarded. If the person fails to show, the prize is forfeited. For all drawings \$1000 or more, the staff present shall take down the possible winner’s driver’s license number found in the Player Tracking System. The possible winner must designate a 1 hour window within the following 24 hours of the drawing time to return to claim their prize by presenting the driver’s license that matches the driver’s license number that was logged the day previous. If the person fails to show, the prize is forfeited.

**5. Method of Entry:**

a. **Virtual Drawing:** Entries will be earned from March 1st until drawing times on the 30th Customers playing at any BDG machine with their Player’s Club Card during specified promotional times will earn virtual entries into drawings. Winners must be found on

Saturdays: March 2nd, 9th, 16th, 23rd & 30<sup>th</sup>. Once chosen and called, the winner of the drawing will have 5 minutes to report to the Player's Club to claim their prize or Entries will be earned from March 1st until drawing times on the 30<sup>th</sup>. Customers playing at any BDG machine with their Player's Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$25 of coin played. No limit on entries. To activate their entries on non-Saturdays, players must play with their Players club card on any VLT machine at any point 8:00:01pm-9:29:59pm before the drawing announce time of 10pm drawing on the day of the drawing to ensure activation. To activate their entries on Saturdays, players must play with their Players club card on any VLT machine at any point 5:00:01pm-9:29:59pm before the 10pm drawing on the day of the drawing to ensure activation. Players MUST be present to win.

On March 2nd the drawing will be for any carryover plus \$6,000. The maximum amount of carryover cash would be \$250 (No winners from 1st) for a total possible maximum of \$6,250. Drawings also taking place that night include \$250 Free Play drawings hourly from 5 to 9pm.

On March 9th the drawing will be for any carryover plus \$6,000. The maximum amount of carryover cash would be \$1,500 (No winners from 3rd to the 8th) for a total possible maximum of \$7,500. Drawings also taking place that night include \$250 Free Play drawings hourly from 5 to 9pm.

b. **Hot Seat:** Customers playing at any BDG machine with their Player's Club Card during specified promotional times will be eligible for Hot Seat draws. Winners will be chosen at random using our player tracking system. The winner will have 5 minutes to report to the Player's Club to claim their prize or another name will be chosen until a winner is found. Player must have valid identification.
