

**BATAVIA DOWNS GAMING**  
**“Hot Hit IGT Drawings”**

**Official Rules**

- 1. Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any employees of sponsors and affiliates of the drawing prize and their immediate family members who live in the same household will be ineligible to win the drawing. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. - 3. Contest Period:**  
**Virtual Drawings:** Earn Entries from April 1st until drawing times on Saturday, April 24, 2021. Saturday’s April 3, 10, 17, 24 2021 at 7pm, 8pm, and 9pm.  
  
**Hot Seat Drawings:** Saturday’s April 3, 10, 17, 24 2021 3pm-6:30pm half-hourly.
- 4. Method of Entry:**  
**Hot Seat:** Customers playing at any IGT/Spielo machine with their Player’s Club Card during specified promotional times will be eligible for Hot Seat draws. One (1) Winner per half-hour will be chosen at random using our player tracking system. Players will have 5 minutes to report to player’s club or another name will be selected. Player must have valid identification. Promotional giveaways are executed using the highest standards of integrity.

**Virtual Drawing:** *To activate entries, players must play with their OWN player's club card between (TIMES LISTED IN DRAWING) before drawing announce times. Once drawn, the earliest play activating entries will be checked by staff to confirm play by player with their own card. If a player is found to not be playing with their own card at that time, they will NOT be deemed an eligible winner for that drawing and a new winner will be selected.* Entries will be earned from April 1st until drawing times on the 24th. Customers playing at any BDG machine with their Player's Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$5 of coin played, must play with and remove their card 2 hours to ½ hour before the drawing announcement and must earn 1 point on any IDG/Spielo machine. No limit on entries.

**7pm Saturdays:** To activate their entries players must play with and remove their Players club card on any VLT machine at any point 5:00:01pm to 6:29:59pm, and earn 1 point on any IDG/Spielo machine before the drawing on the day of the drawing to ensure activation. Players MUST be present to win.

**8pm Saturdays:** To activate their entries, players must play with and remove their Players club card on any VLT machine at any point 6:00:01pm to 7:29:59pm, and earn 1 point on any IDG/Spielo machine before the drawing on the day of the drawing to ensure activation. Players MUST be present to win.

**9pm Saturdays:** To activate their entries, players must play with, and remove their Players club card on any VLT machine at any point 7:00:01pm to 8:29:59pm, and earn 1 point on any IDG/Spielo machine before the drawing on the day of the drawing to ensure activation. Players MUST be present to win.
