PICK-6 CONTEST

OFFICIAL RULES

1. Entries limited to **one per person must be a Players Club member to participate**. Any person submitting more than one entry (contest form) will be disqualified. Participants must be **18 years or older**. No purchase necessary.
2. Pick-6 contest players are to select one (1) horse in each Batavia Downs Gaming & Hotel contest races (Races 4 – 9). All contest forms must be completed in full between 4:30 pm and Post Time of the 4th race at Batavia Downs Gaming & Hotel and deposit in the designated box located next to Player's Club.
3. **Prize structure:**
December 7 & 14 Pick-6 contest pool is \$1,000 guaranteed.
December 7 & 14 Consolation \$250 Pick-6 Pool.
4. **To win \$1,000 prize pool December 7 & 14 Pick-6 contests**
Patrons must select the winning horse in each of the contest races (races 4–9), based on the official order of finish. In the December 7 and December 14 prize money is **ONLY** awarded if all six (6) winners in the Pick-6 races (races 4 – 9) have been correctly selected.
5. **To win \$250 Consolation Pool December 7 & December 14 Pick-6 contests**
In the event all six winners are not selected, patron's selecting 5 out of 6 winners in any of the Pick-6 races will win or share in the consolation pool of \$250. Patrons must select at least five winners in the Pick-6 contest races, (races 4 – 9). Patron's selecting less than five winners are not eligible to share in consolation pool. The consolation pool is **ONLY** awarded if no one has selected all six winners.
6. In the event of a late scratch, patron's selection in the race the scratch occurred is automatically transferred to the post time favorite. A late scratch is defined as a scratch that occurs after the changes are announced by public address announcer at 5:30 pm. It is the patron's responsibility to know the early scratches. In the event patron selects an early scratch, they will not receive the post time favorite.
7. In the event of a tie in either Pick-6 contest, Dec 7 or Dec 14, all prize monies will be divided equally, be it the \$1,000 pool or the \$250 pool, amongst all winning pick-6 contest players.
8. The decision of the Batavia Downs Gaming & Hotel Rules Committee will be final in all matters connected to and related to this contest. The Rules Committee will review all objections and/or rules interpretations. Contestant agrees to abide by all rules and to accept any decisions rendered by Batavia Downs Gaming Rules Committee.
9. Entry into this contest constitutes an agreement by the participant that his/her name and likeness may be used for promotional purposes without compensation.
10. Anyone employed by Batavia Downs Gaming & Hotel, Western Region Off-Track Betting and his or her immediate family (or anyone living in same household) will not be allowed to participate. Drivers, trainers, owners or personnel holding a harness racing license that are licensed by the New York State Gaming Commission for 2019, will not be eligible to participate.
