BATAVIA DOWNS GAMING "Jan/Feb Lottery 2nd Chance Drawings" FPAF 20-01-09 Official Rules

- 1. Eligibility: This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes.
