

**BATAVIA DOWNS GAMING**  
**“October Tiered Rewards/Dinners”**  
**FPAF 20-10-10**  
**Official Rules**

1. **Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any employees of sponsors and affiliates of the drawing prize and their immediate family members who live in the same household will be ineligible to win the drawing. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules. Players may only be awarded one “like” prize per drawing date. (I.E. if a player is awarded a \$500 Cash prize they are eligible for any other drawings that night except for another, separate \$500 Cash Prize).
2. **Sponsor:** (as defined below), Western Regional OTB, Batavia Downs Gaming, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer on-line system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications, data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. This also includes any malfunction with respect to a Player’s Club card. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrants ineligible. Batavia Downs Staff will announce winners over PA system. It is the responsibility of eligible entrants to be in an area where winner’s names can be heard over PA system.
3. **Check in Period: On designated dates each month:**
  - a. **Birthdays:** Elite Only – any day within the month of October 2020.
  - b. **Preferred:** Can be redeemed once a month, once a day, on any of the following dates: After 8am on Thursday, October 6, 13, 20, 27 2020 - cannot be redeemed with any Bonus offers, Premier, President’s Bonus, or Elite.
  - c. **Premier:** Can be redeemed once a day, once per month on any Sunday through Thursday in October 2020 8am-9pm – cannot be redeemed the same day as any Bonus Offer, Elite, President’s Bonus, or Preferred.
  - d. **Elite/President’s Bonus:** Can be redeemed once a month, once a day, on any day in October 2020 between 8am – 9pm, but cannot be redeemed the same day as any Bonus Offers, Premier, President’s Bonus/Elite, or Preferred.
  - e. **Elite/President’s Club Bonus Postcard:** Can be redeemed once a month, once a day, on any day in October 2020 between 8am – 9pm, but cannot be redeemed the same day as a Premier, President’s Bonus/Elite, or Preferred.
  - f. **Jackpot:** Throughout the month of October, reservations are required.
4. **Rules:** If a present winner cannot produce ID, the following protocol shall be followed: For all Drawings \$999 or less the Batavia Downs staff present shall take down the possible winner’s driver’s license number found in the Player Tracking System. At any time within 24 hours, the possible winner must return, WITH the driver’s license that matches

the driver's license number that was logged the day previous and the prize will be awarded. If the person fails to show, the prize is forfeited. For all drawings \$1000 or more, the staff present shall take down the possible winner's driver's license number found in the Player Tracking System. The possible winner must designate a 1 hour window within the following 24 hours of the drawing time to return to claim their prize by presenting the driver's license that matches the driver's license number that was logged the day previous. If the person fails to show, the prize is forfeited.

5. **Method of Entry:**

The top persons that are Elite tier who have a birthday in the month will be eligible for the Birthday dinner any day within their birthday month.

Persons with over \$100,000 coin played (10,000+ base points) for the specified time period will be designated as an "Elite" level Player and eligible for Elite rewards based off rated carded play.

Persons with over \$70,000 coin played (7,000-9,999 base points) for the specified time period will be designated as a "Premier" level Player and eligible for Premier rewards based off of rated carded play.

Persons with over \$35,000 coin played (3,500-6,999 base points) for the specified time period will be designated as a "Preferred" level Player and eligible for Preferred rewards based off of rated carded play.

Persons with \$0-\$34,999 coin played (0-3,499 base points) for the specified time period will be designated as a "Select" level Player.

6. **Reward Distribution:** Upon presentation of Birthday, Elite, President's Bonus, Premier, Preferred, or Jackpot invitation, Player's Club will give the member free play and/or a receipt for the meal. The person's name on the invite MUST be the person checking in for the meal/free play and/or gift. Reservations are recommended for Premier, President's Bonus, or Elite dinner at Fortune's by player. If the player misses their designated reservation time they will be pushed to the next available open time, late reservations do not guarantee first dinner choice. NO TAKEOUTS allowed for any dinners at Fortune's. Guest MUST be present in order to receive dinner.

a. If Player does not have designated postcard or letter, their name will be matched with a tier level indicated on their account that indicates them eligible to receive that month's invite (Free Play, Meal and/or gift) If the indication appears, they will receive the Free Play, Dinner and/or gift as if they had the invite. Promotional giveaways are executed using the highest standards of integrity.

7. **Prizes: Birthday:** A meal and \$50 in free play for them and \$25 for their guest. **Preferred:** \$25 in free play and \$10 for their guest to be redeemed on (1) one of the (4) four dates provided on their postcard. **Premier:** A meal and \$35 free play for them and a meal and \$15 for their guest. Only can be redeemed once in the month of October, Sunday through Thursday **Elite/President's Bonus:** A meal and \$75 free play for them; a meal and \$25 free play for their guest. Meal may be redeemed on one date within the month of October. **Elite/President's Club Bonus Postcard:** A meal and \$75 free play for them; a meal and \$25 free play for their guest. Meal may be redeemed on one date within the month of October. **Jackpot:** Meal for them and a guest in the month of October.

8. **Prize Acceptance:** By accepting their prize, winner acknowledges any and all restrictions, expiration dates and liabilities. Winners may be required to complete, execute and return and Affidavit of Eligibility/Release of Liability and (except where prohibited) a Publicity Release and a completed IRS W-9 form within 14 days of issuance. Failure to return all required documents in this time period might result in the winner being disqualified or an alternate winner selected. No substitution for a prize by the winner will be permitted unless otherwise stated in the official rules. If necessary due to unavailability, a prize of equal or greater value will be awarded at the discretion of the Sponsor. Prizes are not transferable, assignable or redeemable for cash, unless otherwise stated. The winner's entry and acceptance of any prize constitutes permission for the Sponsor to use said winner's name, photograph, likeness, statements, biographical information, voice and address (city and state), in all forms of media, in perpetuity, without notice or further compensation.

9. **Terms and Conditions:** This sweepstakes is subject to all applicable federal, state and local laws. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sweepstakes Administrator, and waive any right to claim ambiguity in the sweepstakes or these Official Rules. Winners and entrants also agree to release, discharge, indemnify and hold harmless the Sponsor, vendors associated with this sweepstakes, New York Lottery and

the respective officers and employees of these entities, from and against any claims, damages or liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, or participation in this sweepstakes. Any person attempting to defraud or in any way tamper with the sweepstakes mechanics and/or implementation will be declared ineligible and may be prosecuted to the full extent of the law. Batavia Downs reserves the right to make changes in the rules of this contest, which will become effective upon announcement.
