Official Rules

- 1. Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies are ineligible to participate in the program. Any employees of sponsors and affiliates of the drawing prize and their immediate family members who live in the same household will be ineligible to win the drawing. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules. Players may only be awarded one “like” prize per drawing date. (I.E. if a player is awarded a \$500 Cash prize they are eligible for any other drawings that night except for another, separate \$500 Cash Prize).

False and/or deceptive entries or acts shall render entrants ineligible. Batavia Downs Staff will announce winners over PA system. It is the responsibility of eligible entrants to be in an area where winner’s names can be heard over PA system.

- 4. Method of Entry:**
Hot Seat: Customers playing at any BDG machine with their Player’s Club Card during specified promotional times will be eligible for Hot Seat draws. One (1) Winner will be chosen in succession at random using our player tracking system. All players must remain in their seats until the prize patrol finds them, an announcement will be made once the winner is found. Anyone found playing at the same bank as the winner will receive a \$10 free

play. Player must have valid identification. Promotional giveaways are executed using the highest standards of integrity.

Virtual Drawings:

Entries will be earned from March 1st until drawing times on the 28th. Customers playing at any BDG machine with their Player's Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. To activate their entries on non-Saturdays, players must play with and remove their Players club card on any VLT machine at any point between 8:00:01-9:29:59 before the drawing announce time of 10pm drawing on the day of the drawing to ensure activation. To activate their entries on Saturdays, players must play with and remove their Players club card on any VLT machine at any point 7:00:01-9:29:59pm before the drawing on the day of the drawing to ensure activation. Players MUST be present to win.

Starting March 1st nightly drawings will be held at 10pm for \$250 Cash. Only 1 winner drawn per drawing except for 10pm drawings on March 7th, 14th, 21st and 28th. If the winner is not present, the prize that night is not given out and the amount is added to the next day's 10pm drawing. Winners must be found for 10pm drawings on Saturdays: March 7th, 14th, 21st and 28th once chosen and called, the winner of the drawing will have 5 minutes to report to the Player's Club to claim their prize or a new name, different than all previously selected names, will be drawn. Players MUST be present to win.

On March 7th the drawing will be for any carryover plus \$8,000. The maximum amount of carryover cash would be \$1,500 (No winners from 1st - 6th) for a total possible maximum of \$9,500.

On March 21st the drawing will be for any carryover plus \$8,000. The maximum amount of carryover cash would be \$1,500 (No winners from 15th - 20th) for a total possible maximum of \$9,500.

Drawing at 7pm for \$1,000 Cash as well as any carryover cash. The maximum amount of carryover cash would be \$1,500 (No winners from 22nd to 27th) as specified above, only 1 person will be drawn for this drawing. To activate 7pm entries, players must play with and remove their Players club card on any VLT machine at any point between 4:00:01-6:29:59 before the drawing announce time of 7pm drawing on the day of the drawing to ensure activation. If the person is not present, the money will roll to the 8pm Drawing.

Drawing at 8pm will be for \$1,250 Cash plus any carryover cash from the week and/or 7pm drawing. Again, only 1 person will be drawn for this drawing. To activate 8pm entries, players must play with and remove their Players club card on any VLT machine at any point between 5:00:01-7:29:59 before the drawing announce time of 8pm drawing on the day of the drawing to ensure activation. If the person is not present, the money will roll to the 9pm Drawing.

Drawing at 9pm will be for \$1,500 Cash. Again, only 1 person will be drawn for this drawing. To activate 9pm entries, players must play with and remove their Players club card on any VLT machine at any point between 6:00:01-8:29:59 before the drawing announce time of 9pm drawing on the day of the drawing to ensure activation. If the person is not present, the money will roll to the 10pm Drawing.

Drawing at 10pm on Saturday the 28th, a winner must be found. We will draw for \$30,000 plus any carryover cash from previous drawing. Once chosen and called, the winner of the drawing will have 5 minutes to report to the Player's Club to claim their prize or a new name, different than all previously selected names, will be drawn. Players MUST be present to win. To activate 10pm entries, players must play with and remove their Players club card on any VLT machine at any point between 7:00:01-9:29:59 before the drawing announce time of 10pm drawing on the day of the drawing to ensure activation.

Again, only 1 person will be drawn for this drawing. If the person is not present, the money will roll to the 10pm Drawing. At 10pm on Saturday the 28th, a winner must be found.
