BATAVIA DOWNS GAMING "March Pot-O-Gold Progressive" 23-03-21 Official Rules

- 1. Eligibility: This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates, and agencies are ineligible to participate in the program. Hot Seat: Customers playing at any BDG machine with their Player's Club Card during specified promotional times will be eligible for Hot Seat draws. One (1) winner will be chosen in succession at random using our player tracking system and must have their player's club card. Winners will have five (5) minutes to claim their prize, or another name, different from all other winners will be selected. Promotional giveaways are executed using the highest standards of integrity.

Virtual Drawings:

Entries will be earned from March 1st until drawing times on the 25th. Customers playing at any BDG machine with their Player's Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. To activate their entries on non-Saturdays, players must play with and remove their Players club card on any VLT machine at any point between 8:00:00pm and 9:00:00pm. Drawing will take place at 9:20pm, and 1st eligible winner will be announced at 9:30pm. Players MUST be present to win. Once chosen and called, the winner will have 5 minutes to report to Player's Club to claim their prize or a new name, different than all previously selected names, will be drawn. If unable to find a winner in 5 draws, they will then move to a hot seat drawing.

Starting March 1st nightly drawings will be held at 9:30pm for \$250 Cash. Only 1 winner drawn per drawing except for 9:30pm drawings on March 4, 11, 18, 25. If the winner is not present, the prize that night is not given out and the amount is added to the next day's 9:30pm drawing. To activate their entries, players must play with and remove their Players club card on any VLT machine at any point between 8:00:00pm and 9:00:00pm. Drawing will take place at 9:20pm, and 1st eligible winner will be announced at 9:30pm. Winners must be found for 9:30pm drawings on Saturdays: March 4, 11, 18, 25, 2023. Once chosen and called, the winner of the drawing on Saturdays will have 5 minutes to report to the Player's Club to claim their prize or a new name, different than all previously selected names, will be drawn. Players MUST be present to win.

6. Prizes:

Hot Seat: \$250 Free Play on Saturdays

Virtual: Sundays-Fridays in March \$250 Cash Progressive Drawings

On March 4th the drawing will be for any carryover plus \$5,000. The maximum amount of carryover cash would be \$750 (No winners from 1st - 3rd) for a total possible maximum of \$5,750.

On March 11th the drawing will be for any carryover plus \$5,000. The maximum amount of carryover cash would be \$1,500 (No winners from 5th - 10th) for a total possible maximum of \$6,500.
