

BATAVIA DOWNS GAMING
“Collect and Win”

Official Rules

1. **Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, who hold a key license, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-ground employees, and vendors directly associated with this contest, their subsidiaries, affiliates, and agencies are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant, or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state, and local rules and regulations apply. Voids where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.
2. **Sponsor:** (as defined below), Western Regional OTB, Batavia Downs Gaming, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer on-line system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications, data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. This also includes any malfunction with respect to a Player’s Club card. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrant’s ineligible. Batavia Downs Staff will announce winners over PA system. It is the responsibility of eligible entrants to be in an area where the winner’s names can be heard over the PA system.
3. **Contest Period:** May 1st beginning at 8am- May 31, 2024, 11:59pm
4. **Method of Entry:** Beginning at 8am on October 1st and while game pieces last, Player’s Club members may receive one (1) Official Game Pieces per day for the Collect and Win Game Board by checking into the Odds-on Promotions kiosk. Free play & cash prizes can only be picked up or redeemed during Player’s Club hours. Customers that receive instant win prize game pieces will win prizes as defined in section below. Customers that collect matching game pieces on Collect and Win Game Board will win prizes as defined in section below. There is a limit of one, (1) Game Piece per day per person for this promotion unless a separate promotion day/time allows an extra piece to be earned.

Player’s club members can earn double game pieces and the 5 base points must be earned during these times on the following days to receive double pieces:

- Tuesday, May 7, 14, 21, 28, 2024 from 8am to 11:59pm

A valid photo ID must be presented to the Player’s Club representative to redeem an instant win game piece or matching game pieces. No duplicates, reproductions, or facsimiles of Collect and Win game pieces will be accepted. Presenting false and/or deceptive entries or acts to Player’s Club shall render entrants ineligible. All prizes must be claimed at Player’s Club by Friday, May 31, 2024, at 11:59pm.
