

BATAVIA DOWNS GAMING
“March Progressive”

Official Rules

- 1. Eligibility:** This contest is open to all active members of the Batavia Downs Gaming Players Club, who are 18 years or older, and abide by the rules and regulations of the Players Club. Individuals who have been excluded from the Gaming (voluntarily or involuntarily) are not eligible to win any prizes. Employees of Western Regional OTB, Batavia Downs Gaming and its subsidiaries and affiliates are ineligible to participate. Persons who are employed by the NY State Gaming Commission and any immediate family members residing in the same household of any of the foregoing individuals are also ineligible to participate in the program. Employees of any other New York VLG facilities, and any immediate family members residing in the same household, are also ineligible to participate in the program. People licensed as on-the-ground employees, and vendors directly associated with this contest, their subsidiaries, affiliates, and agencies are ineligible to participate in the program. Any employees of sponsors and affiliates of the drawing prize and their immediate family members who live in the same household will be ineligible to win the drawing. Any licensee, registrant, contractor, subcontractor, consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant, or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state, and local rules and regulations apply. Voids where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules. Players may only be awarded one “like” prize per drawing date. (I.E., if a player is awarded a \$500 Cash prize, they are eligible for any other drawings that night except for another, separate \$500 Cash Prize).
- 2. Sponsor:** (as defined below), Western Regional OTB, Batavia Downs Gaming, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer on-line system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications, data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. This also includes any malfunction with respect to a Player’s Club card. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrant’s ineligible. Batavia Downs Staff will announce winners over PA system. It is the responsibility of eligible entrants to be in an area where the winner’s names can be heard over the PA system.
- 3. Drawing Rules (if applicable):** If a present winner cannot produce ID, the following protocol shall be followed: For all Drawings \$999 or less the Batavia Downs staff present shall take down the possible winner’s driver’s license number found in the Player Tracking System. At any time within 24 hours, the possible winner must return, WITH the driver’s license that matches the driver’s license number that was logged, and the prize will be awarded. If the person fails to show, the prize is forfeited. For all drawings, \$1000 or more, the staff present shall take down the possible winner’s driver’s license number found in the Player Tracking System. The possible winner must designate a 1-hour window within the following 24 hours of the drawing time to return to claim their prize by presenting the driver’s license that matches the driver’s license number that was logged. If the person fails to show, the prize is forfeited. If a winner is not found after 3 virtual drawing pulls, then the drawing will then become a hot seat drawing.
- 4. Contest Period:**

 - **Hot Seat Drawings:**

5. Method of Entry:

Hot Seat: Customers playing at any BDG machine with their Player’s Club Card during specified promotional times will be eligible for Hot Seat draws. One (1) winner will be chosen in succession at random using our player tracking system and must have their player’s club card. Winners will have five (5) minutes to claim their prize, or another name, different from all other winners will be selected. Promotional giveaways are executed using the highest standards of integrity.

Virtual Drawings:

Entries will be earned from March 1st until drawing times on the 28th. Customers playing at any BDG machine with their Player’s Club Card during specified promotional times will earn virtual entries into drawings. Patrons will earn (1) entry for every \$5 of coin played. No limit on entries. To activate their entries on non-Saturdays, players must play with and remove their Players club card on any VLT machine at any point between 8:00:00pm and 9:00:00pm. Drawing will take place at 9:20pm, and 1st eligible winner will be announced at 9:30pm. Players MUST be present to win. Once chosen and called, the winner will have 5 minutes to report to Player’s Club to claim their prize or a new name, different than all previously selected names, will be drawn.

Starting March 1st nightly drawings will be held at 9:30pm for \$250 Cash. Only 1 winner drawn per drawing except for 9:30pm drawings on Saturday, March 7, 14, 21, 28th. If the winner is not present, the prize that night is not given out, and the amount is added to the next day's 9:30pm drawing. Winners must be found on 9:30pm drawings on Saturdays: March 7, 14, 21, 28th. Once chosen and called, the winner of the drawing on Saturdays will have 5 minutes to report to the Player’s Club to claim their prize or a new name, different than all previously selected names, will be drawn. Players MUST be present to win. If unable to find a winner in 3 draws, they will then move to a hot seat drawing.

6. Prizes:

Hot Seat: \$250 Free Play on Saturdays {Does not include March 14th due to another event}

Virtual: Sundays-Fridays in March \$250 Cash Progressive Drawings

On March 7th the drawing will be for any carryover plus \$7,500. The maximum amount of carryover cash would be \$1,500 (No winners from 1st to 6th) for a total possible maximum of \$9,000

On March 14th the drawing will be for any carryover plus \$7,500. The maximum amount of carryover cash would be \$1,500 (No winners from 8th to 13th) for a total possible maximum of \$9,000

On March 21st the drawing will be for any carryover plus \$7,500. The maximum amount of carryover cash would be \$1,500 (No winners from 15th to 20th) for a total possible maximum of \$9,000

On March 28th, the drawings will be for any carryover plus \$21,500. The maximum amount of carryover cash would be \$1,500 (No winners from 22nd to 27th) for a total possible maximum of \$23,000

- 7. Prize Acceptance:** By accepting their prize, the winner acknowledges any and all restrictions, expiration dates and liabilities. Winners may be required to complete, execute, and return and Affidavit of Eligibility/Release of Liability and (except where prohibited) a Publicity Release and a completed IRS W-9 form within 14 days of issuance. Failure to return all required documents in this time might result in the winner being disqualified or an alternate winner selected. No substitution for a prize by the winner will be permitted unless otherwise stated in the official rules. If necessary due to unavailability, a prize of equal or greater value will be awarded at the discretion of the Sponsor. Prizes are not transferable, assignable, or redeemable in cash, unless otherwise stated.
